1.1 In this Deed of Amendment, unless inconsistent with or otherwise indicated by the context: -


- 1.1.1 "the trust" is The Zululand Rhino Reserve Foundation Trust, Trust No. IT 175/2011PMB


The current trustees are desirous of Amending the name of the Trust known as The Zululand Rhino Reserve Foundation Trust to The Zululand Conservation Trust
